

## University of Utah School of Architecture Articulation Agreement

University of Utah College of Architecture + Planning  
Salt Lake Community College School of Arts Communication & Media

This Agreement (the "Agreement") is entered into as of the last signature date below by and between Salt Lake Community College, a body politic and corporate of the State of Utah and a public institution of higher education and the University of Utah School of Architecture at the University of Utah, a body politic and corporate of the State of Utah and a public institution of higher education. The purpose of this Agreement is to articulate the terms of collaboration between the University of Utah School of Architecture (SoA) at the University of Utah (UU) and the Architectural Technology Department in the Division of Visual Art & Design in the School Arts, Communication & Media at Salt Lake Community College (SLCC) that will begin January 1, 2019 /2019, all as more specifically described herein.

### Course Articulation

The School of Architecture in the College of Architecture + Planning at the University of Utah and the Architectural Technology Department in the School of Arts, Communication & Media at Salt Lake Community College agree to the articulation of transfer credit as outlined in this agreement.

## **Contract Courses**

To help facilitate a transition to the School of Architecture's new curriculum (updated in 2018-19), the College of Architecture + Planning will offer the following contract course for the term indicated:

CMP 2010 Design Ecologies - Spring 2019

The contract for this course will be reviewed and renewed, as needed, contingent on the outcome of this review. This agreement will remain in effect unless terminated in writing by either institution.

## **Student Success**

The College of Architecture + Planning and SLCC advising faculty & staff agree to foster a strong student success focus through early and frequent faculty visits, transfer advising sessions, and transfer workshops. Through visits to the SLCC campus and classes, and general information sessions, the College of Architecture + Planning faculty and transfer advisor will offer information about transferring and preparation for applying to the Architecture program in the School of Architecture.

## **Co-Curricular Activities**

The College of Architecture + Planning and School of Architecture will work to include SLCC students in a variety of appropriately themed co-curricular activities, including activities sponsored by the local chapter of the American Institute of Architecture Students, special lectures and workshops, visits to local architecture firms, and student-oriented social events.

## **Liability**

Both Salt Lake Community College and the University of Utah are governmental entities under the Governmental Immunity Act, §63G-7-101 to -904 (2011), as amended (the "Act"). Notwithstanding any provision to the contrary herein, there are no indemnity obligations between these parties. Subject to and consistent with the terms of the Act, each party shall be liable only for its own negligent acts or omissions or those of its employees, officers, and agents while engaged in the performance of the obligations under this Agreement, and neither party shall have any liability whatsoever for any negligent act or omission of the other party, its employees, officers, or agents. Neither party waives any defenses or limits of liability available under the Act and other applicable law. Each party carries insurance through the State Risk Manager of the State of Utah up to the limits required by the State Risk Manager of the State of Utah and applicable law. Nothing in this Agreement shall require either party to carry different or additional insurance. It is not the intent of either party to incur by contract any liability for the operations, acts, or omissions of the other party or any third party and nothing in this Agreement shall be so interpreted or construed. In the event of any conflict, inconsistency, or discrepancy between the provisions of this paragraph and any other

provisions of this Agreement, the provisions of this paragraph of the Agreement shall govern.
