Honors College Articulation Agreement

University of Utah Honors College | Salt Lake Community College

This Agreement (the "Agreement") is entered into as of the last signature date below by and between Salt Lake Community College, a body politic and corporate of the State of Utah and a public institution of higher education and the Honors College at the University of Utah, a body politic and corporate of the State of Utah and a public institution of higher education. The purpose of this Agreement is to articulate the terms of collaboration between the Honors College at the University of Utah (UU) and the Honors Program at Salt Lake Community College (SLCC) that will begin Fall 2019, all as more specifically described herein.

The Honors College at the University of Utah and the Honors Program at SLCC agree that the following courses will be accepted as equivalent in transfer:

The Honors College at the University of Utah and the Honors Program at SLCC agree to the following stipulations regarding admission:

- 1. Admission to the University of Utah Honors College is contingent upon acceptance to the University of Utah as a Bachelor's degree seeking student.
- 2. SLCC students accepted into the UUHC must complete the following criteria:
 - a) Complete an AA/AS degree from SLCC.
 - b) Graduate with a cumulative GPA of 3.5.
 - c) Engage in two formal High-Impact Practices (HIPs). One will be a strong ePortfolio. The second will be chosen by the student, and may include Service-learning, Undergraduate Research, Writing Intensive Course, Study Abroad, a Common Reading experience, or another HIP that meets with the approval of SLCC's Honors program.

- d) Pass all three of the following: the three 1-credit Honors seminars (SS), the Intellectual Traditions Course (HU), and Honors Writing (EN).
- e) Participate in two Enrichment Experiences per semester and write descriptive/reflective entries about them in their ePortfolio.

The Honors College at the University of Utah and the Honors Program at SLCC further agree that SLCC students must complete the University of Utah New Transfer Orientation and meet with a UUHC advisor. Matriculated, Junior status will be granted to AA/AS graduates from SLCC who meet the academic performance standards presented above.

This agreement will be reviewed annually. Renewal will be contingent on the outcome of these reviews. This agreement will remain in effect unless terminated in writing by either institution.

Liability

Both Salt Lake Community College and the University of Utah are governmental entities under the Governmental Immunity Act, §63G-7-101 to -904 (2011), as amended (the "Act"). Notwithstanding any provision to the contrary herein, there are no indemnity obligations between these parties. Subject to and consistent with the terms of the Act. each party shall be liable only for its own negligent acts or omissions or those of its employees, officers, and agents while engaged in the performance of the obligations under this Agreement, and neither party shall have any liability whatsoever for any negligent act or omission of the other party, its employees, officers, or agents. Neither party waives any defenses or limits of liability available under the Act and other applicable law. Each party carries insurance through the State Risk Manager of the State of Utah up to the limits required by the State Risk Manager of the State of Utah and applicable law. Nothing in this Agreement shall require either party to carry different or additional insurance. It is not the intent of either party to incur by contract any liability for the operations, acts, or omissions of the other party or any third party and nothing in this Agreement shall be so interpreted or construed. In the event of any conflict, inconsistency, or discrepancy between the provisions of this paragraph and any other provisions of this Agreement, the provisions of this paragraph of the Agreement shall govern.
